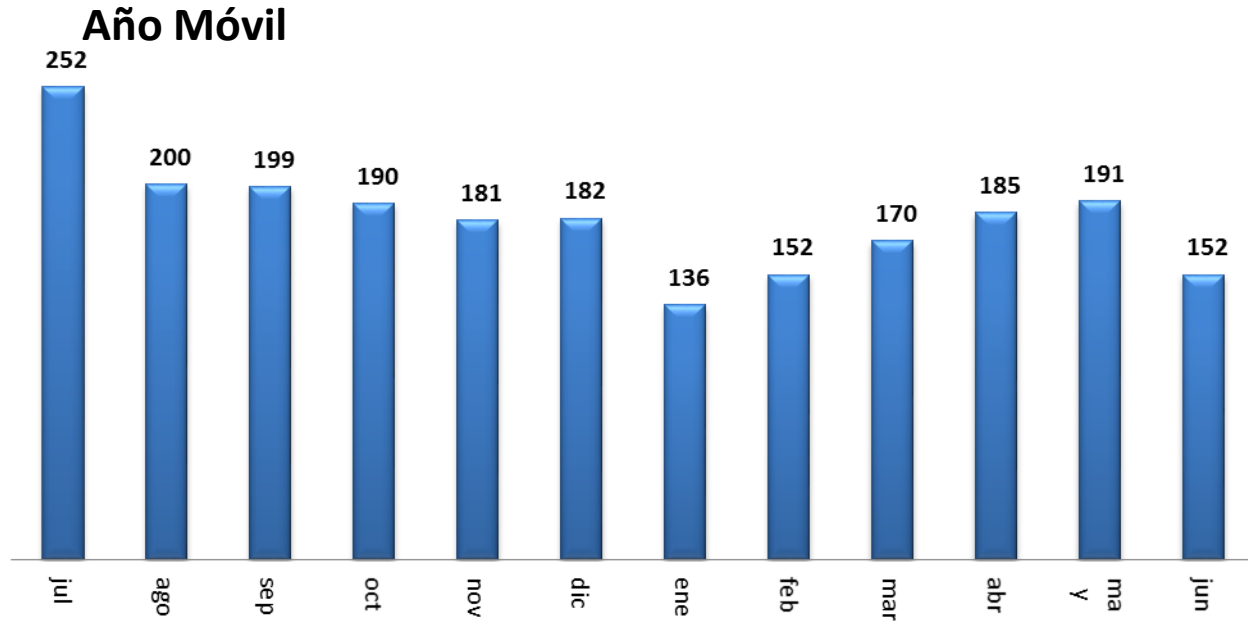

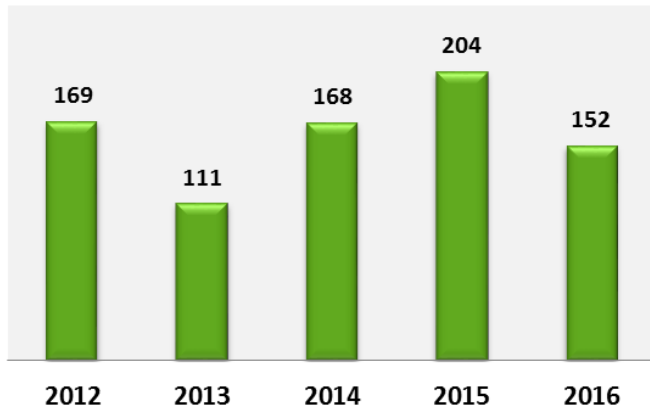


# Evolución Mensual - Número de operaciones

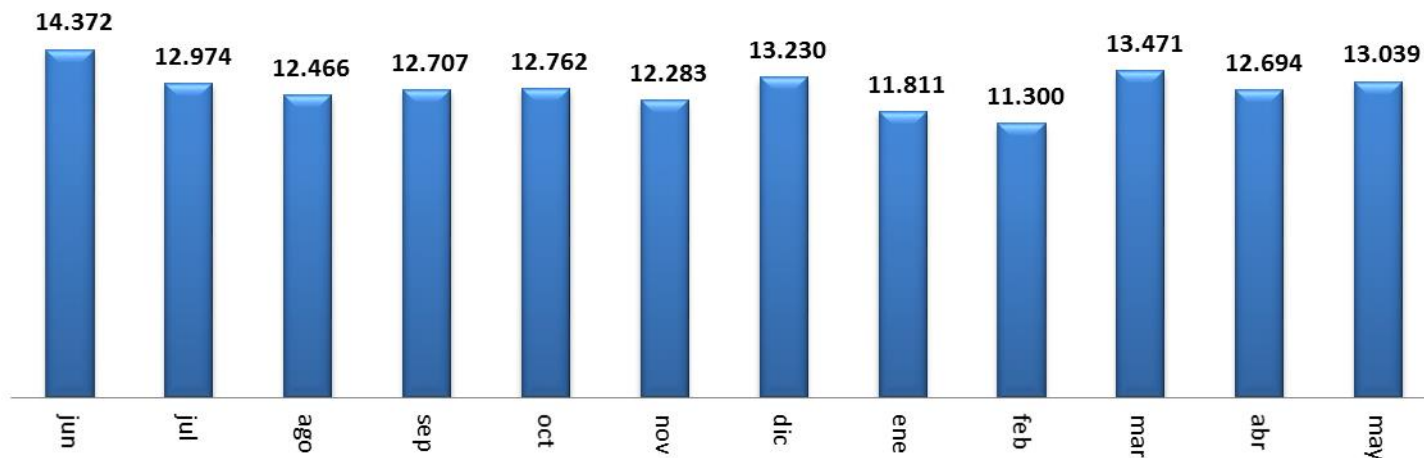

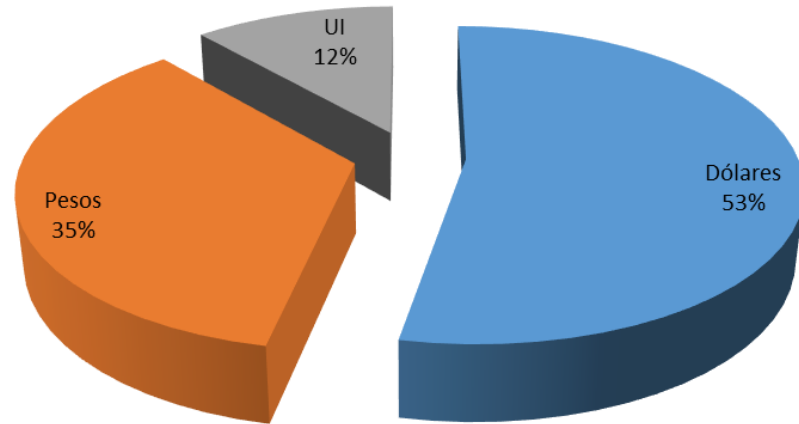

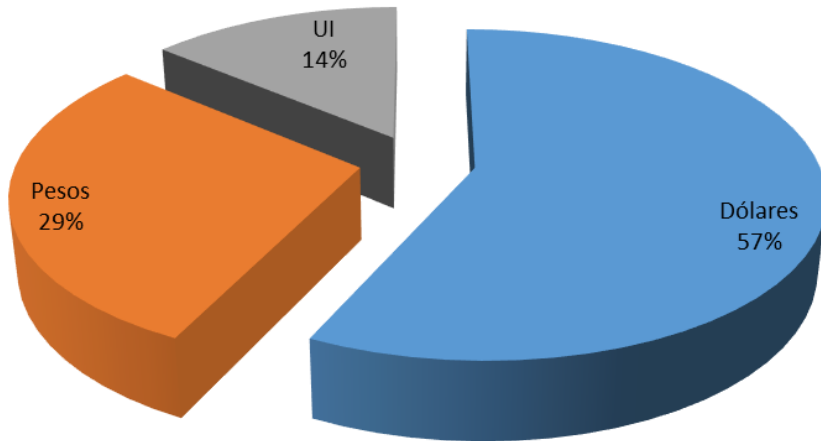


# Distribución por moneda 2016 (Base USD)

## Distribución por Cantidad de garantías



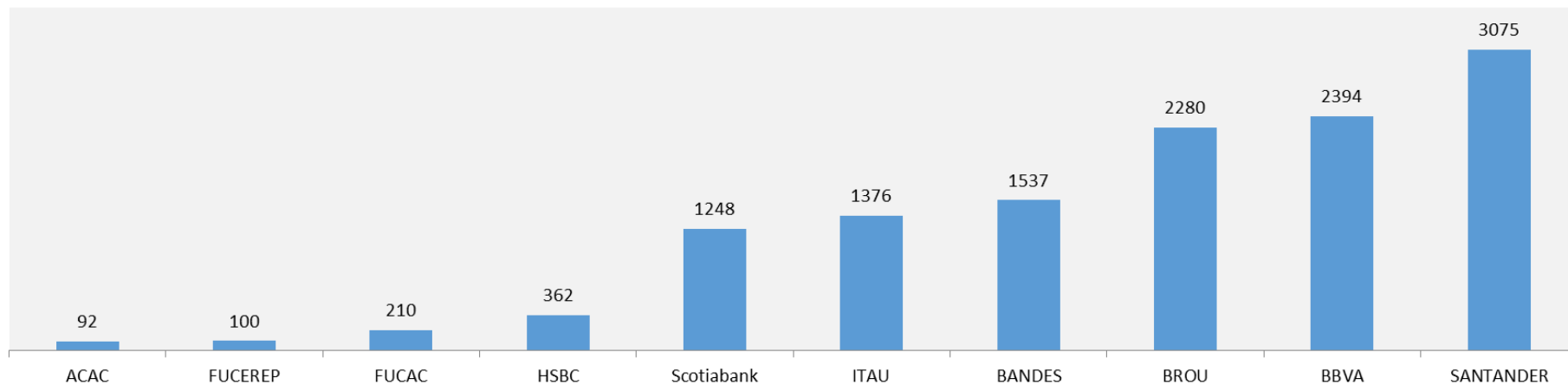
## Distribución por Monto de garantías



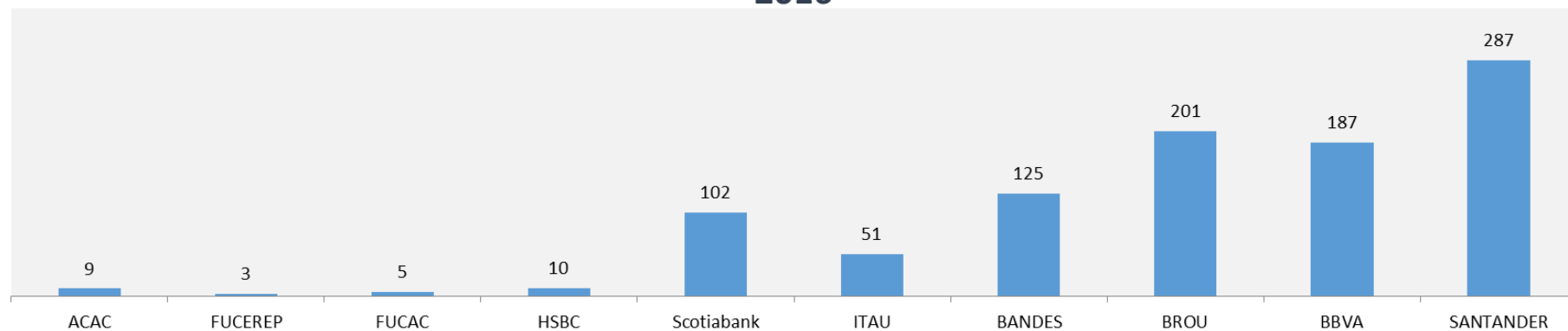
